- 5.4 The Board's mandate is to:
- 5.4.1 Executive member of the Congress resolution.
- 5.4.2 Elect and dismiss the executive director; elect and dismiss the President, Vice President, General Secretary; hire honorary president, vice president, honorary president, and vice president title and so on.
- 5.4.3 Preparations for the convening of the General Assembly.
- 5.4.4 Report to the Congress of the work and financial situation.
- 5.4.5 For determining the absorption or removal; consultants; awarded the title of honorary member.

- 5.9.3 Be responsible for the conduct of business and major activities of the organization.

Chapter VI Asset Management, using the principles of

- 6.1 Sources of funding:
- 6.1.1 Dues.
